Whereas, this office vide Advertisement Notice **No. 08 GMCA of 2026, Dated: 24.04.2026** invited applications from the eligible candidates possessing requisite qualification for filling up tenure posts of Junior Residents in the Government Medical College, Anantnag; and

Whereas, the written test for the said posts was conducted on **1st of June, 2026** at Main Campus Dialgam, GMC Anantnag; and

Whereas, the merit list of the candidates who appeared in the said written test was published vide this office notification dated 16.06.2026; and

Whereas, on the basis of merit secured and vacancies available, 15 candidates were selected vide this office Notification **No. 11 GMCA of 2026, Dated: 03.07.2026**, with directions to report the Establishment Section (Main Campus) of Govt. Medical College, Anantnag for verification of their credentials and documents; and

Whereas, in view of prevailing shortage of staff and the exigencies of patient care, the selected candidates were permitted to join and were allotted to various departments for provisional duties, subject to submission of an affidavit duly attested by 1st Class Magistrate regarding the pending CID Verification reports; and

Whereas the CID Verification report in respect of the candidates mentioned below have been received by this office from the concerned quarters, and upon verification thereof, the below mentioned candidates are engaged as Junior Residents in Government Medical College, Anantnag, **with effect from the date of their initial joining**, for a period of six **(06)** months extendable upto maximum of one **(01)** year subject to the satisfactory performance to be certified by the concerned Head of the Department.

Terms and Conditions:

1. The selected candidates shall have to execute an agreement with the institution on a devised format with regard to the various terms and conditions applicable during academic arrangement. The candidate shall strictly ensure that he/she shall not leave the post (College) before the completion of tenure of six months, however abandoning/terminating of the engagement in the specialty will require one-month prior notice on either side falling which the salary shall not be paid for one month to the incumbent which shall be released on completion of stipulated sanctioned term.

2. The engagement shall be purely temporary and tenure-based and shall not confer any right upon the candidates to claim regular appointment or continuation beyond the prescribed tenure.
3. The engagement shall remain subject to satisfactory performance, conduct, attendance and fulfilment of all applicable conditions, as certified by the concerned Head of Department and approved by the competent authority.
4. The candidates shall discharge duties as assigned by the concerned Head of Department and shall comply with all institutional rules, regulations, duty rosters and instructions issued by the competent authorities from time to time.
5. In the event of unsatisfactory performance, misconduct, unauthorised absence, or violation of any of the terms and conditions of engagement, the engagement shall be liable to be terminated forthwith without any notice to the effect.
6. The tenure of engagement shall initially be for a period of six **(06)** months, extendable upto a maximum of one **(01)** year, subject to satisfactory performance, as certified by the concerned Head of the Department and approval of the competent authority.
7. During the tenure of engagement, the candidate shall be entitled to 7 ½ days of Casual Leave. Any leave beyond the admissible entitlement, if sanctioned by the competent authority, shall be treated as leave without stipend/remuneration, as applicable under the prescribed terms and conditions.
8. No experience certificate shall be issued to a candidate who leaves or discontinues the post of Junior Resident before completion of the prescribed period of six **(06)** months or violates the terms and conditions mentioned here.
9. Department allocation may be altered in the interest of institutional requirements.
10. The services of Junior Resident shall be liable to termination without prior notice in the event of misconduct, participation in any strike or unauthorized cessation of duties or unsatisfactory performance.
11. The engagement shall be full-time and non-practicing in nature. The Junior Resident shall not undertake private practice or any other professional engagement during the period of tenure.
