Terms and Conditions:

1. The above candidate shall have to execute an agreement with the institution on a prescribed format (**Form A of S.O 364**) with regard to the various terms and conditions applicable during academic arrangement. The candidate shall strictly ensure that he/she shall not leave the post (College) before the completion of tenure of six months, however abandoning/terminating in the specialty will require one-month prior notice on either side falling which the salary shall not be paid for one month to the incumbent which shall be released on completion of stipulated sanctioned term.
2. Before joining the Department, the selected candidate shall submit an affidavit in the Establishment Section(Main Campus), Govt. Medical College Anantnag duly attested by the Judicial Magistrate (**1st Class**) to the effect that:
 - a. I understand all the terms and conditions set out in the agreement (Form A of S.O 364 of 2020) and I shall be bound by all such terms and conditions (Form A of S.O 364) duly executed by me.
 - b. If any of the information furnished by me to the college is found wrong at any point of time, I shall be liable to be punished under rules including confiscation of the Registration of the Doctor.

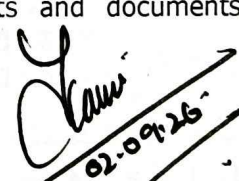

- c. I will not participate in any kind of strike during the period of my tenure engagement. In the event I proceeded on strike, my tenure engagement shall be terminated without any notice as this service is covered under ESMA Act.
 - d. I shall remain disciplined during the tenure period; any kind of misconduct shall make me liable for termination without any prior notice.
 - e. I am not involved in any criminal activity nor is there is any FIR/Court case pending/registered against me in any criminal department or police station/Hon'ble Court.
 - f. I have not previously completed Senior Residency in the concerned discipline, either within or outside of Union Territory of Jammu & Kashmir. I have done _____ months of senior residency/demonstratorship in the concerned discipline at _____ institution/medical college.
 - g. I shall not claim any Experience Certificate in case I leave Senior Resident-ship before completion of first six months.

6. The Senior Residents (Non-PSC) appointed on Academic Arrangement Basis shall be paid as per **S.O 364 of 2020, Dated 27.11.2020**. However, In-service (PSC confirmed) candidates shall be paid salary as per their LPC. The PSC confirmed appointees are required to furnish the NOC from Director Health Services concerned before their joining, failing which they will not be allowed to join and their selection will be cancelled.
7. Those candidates who are not in-service shall be engaged under **S.O 364 of 2020, Dated: 27.11.2020** (Academic Arrangement Basis).
8. The salary of the appointed candidate(s) shall be drawn/dispensed only after recipient satisfactory report of verification of character & antecedents and documents/ testimonials from the concerned quarters.
