Whereas, the merit list of the candidates who appeared in the said written test was published vide this office notification dated 20.01.2026; and


Now, therefore, in light of the above, the selection list in the aforesaid disciplines as indicated in the Annexure A' to this notification is hereby notified for information to the concerned.
