Whereas, this office vide Advertisement Notice No. 10 GMCA of 2025 dated 16.12.2025 invited applications from the eligible candidates possessing requisite qualification for filling up tenure posts of Junior Residents in the Government Medical College, Anantnag; and

Whereas, the written test for the said posts was conducted on **15th of January, 2025** at Main Campus Dialgam, GMC Anantnag; and

Whereas, the final merit list of the candidates who appeared in the said written test was published vide this office notification dated 27.01.2026; and

Now, therefore, on the basis of merit secured and vacancies available, the candidates as annexed in Annexure A to this order are provisionally engaged as Junior Residents under S.O 364 of 2020 dated 27.11.2020, in Government Medical College Anantnag initially for a period of six (06) months extendable upto one year subject to the satisfactory performance to be certified by the concerned Head of the Department.

The selected candidates are directed to join in the office of the Administrative Officer, Govt. Medical College Anantnag within **14 days** from the date of publication of this order and shall be allowed to join on production of following documents in original along with a set of self-attested photocopies of the same for verification:

- i. MBBS Degree Certificate issued by the concerned University/ Institution.
- ii. Internship completion certificate.
- iii. J&K Medical Council Registration Certificate of MBBS.
- iv. Attempt Certificate, if applicable.
- v. Examination marks sheets (All Phases) issued by the concerned University
- vi. Date of Birth Certificate
- vii. Domicile Certificate
- viii. 2 Passport size photographs
- ix. Screening Certificate, if applicable.
- x. Undertaking as per below prescribed format.

Terms and Conditions:

1. The selected candidates shall have to execute an agreement with the institution on a prescribed format (**Form A of S.O 364**) with regard to the various terms and conditions applicable during academic arrangement. The candidate shall strictly ensure that he/she shall not leave the post (College) before the completion of tenure of six months, however abandoning/terminating after six months of the engagement in the specialty will require one-month prior notice on either side failing which the salary shall not be paid for one month to the incumbent which shall be released on completion of stipulated sanctioned term.

- 2. The salary of the appointed candidate(s) shall be drawn/disbursed only after recipient satisfactory report of verification of character & antecedents and documents/ testimonials from the concerned quarters.**
3. Before joining the Department, the selected candidates shall submit an affidavit in the office of the Administrative Officer, Govt. Medical College Anantnag duly attested by the Judicial Magistrate (**1st Class**) to the effect that:
 - a. I understand all the terms and conditions set out in the agreement (Form A of S.O 364 of 2020) and I shall be bound by all such terms and conditions (Form A of S.O 364) duly executed by me.
 - b. If any of the information furnished by me to the college is found wrong at any point of time, I shall be liable to be punished under rules including confiscation of the Registration of the Doctor.
 - c. I will not participate in any kind of strike during the period of my tenure engagement. In the event I proceeded on strike, my tenure engagement shall be terminated without any notice as this service is covered under ESMA Act.
 - d. I shall remain disciplined during the tenure period; any kind of misconduct shall make me liable for termination without any prior notice.
 - e. I am not involved in any criminal activity nor is there is any FIR/Court case pending/registered against me in any criminal department or police station/Hon'ble Court.
 - f. My engagement is strictly provisional till the recipient of verification of documents/testimonials and verification report for character and antecedents from CID. In case adverse report is received from CID, J&K, I shall not claim for continuation of engagement which shall be deemed to have been cancelled ab-initio and shall have no claim for Junior Residency benefits i.e., Experience Certificate and Remuneration.
 - g. I shall not claim any Experience Certificate in case I leave Junior Resident-ship before completion of first six months.
 - h. I will not indulge in any private practice. In case I am found doing private practice my appointment shall be liable for termination without any notice.

Note: The engagement is strictly provisional, subject to verification of documents/testimonials and clearance from the CID. In case of adverse report with regard to their character and antecedents/documents received from concerned authorities, their engagement shall deemed to have been cancelled/disengaged from the date of joining and shall have no claim for Junior Residency benefits i.e., Experience Certificate and Remuneration.
